II.	Balanced Budget Waiver	The HSP agrees that it will not exceed a \$150,927 total consolidated negative margin for 2014-15 and will fund this negative margin out of its working capital.	Non-Compliant. The Hospital had a negative margin of \$947,284 for 2014-15. A Hospital Improvement Plan (HIP) has been submitted to the LHIN outlining proposed strategies to be implemented in 2015-16 and LWDH is moving forward to implement these strategies to move toward balancing the budget by March 31, 2016. The plan includes permanent bed closures and has consulted with the LHIN as required by 7.3 of the 2008-15 H-SAA.
